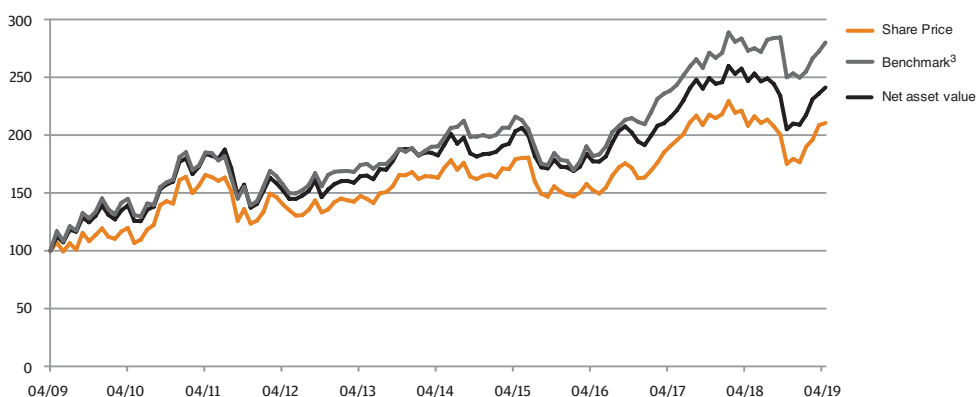

### Market review

The TAIEX Total Return Index (TAIEX) continued its increase, rising 2.8% in April. The TAIEX closed the month at 10,968, its fourth consecutive month of gain. Positive factors supporting the rise continued to include strong second half 2019 forecasts for some technology companies and the U.S. Federal Reserve's accommodating monetary policy. Non-technology sectors also contributed, driven by strong new car sales and increased demand for textiles.

### Fund update

The Fund underperformed the TAIEX by 0.6% in April. The major contributors to performance included Silergy Corp. due to rising demand from China and Hiwin Technologies Corp. on improved machine tool sales. The key detractors from performance included Largan Precision Co., Ltd. due to weaker margins. In non-technology industries, Ginko International Co., Ltd. underperformed due to lower than expected sales.

There is no change to the Fund's core investment approach and the portfolio is concentrated in high conviction quality companies with strong growth profiles. The Fund's portfolio reflects its confidence in the long term growth potential of artificial intelligence, 3D sensing, industrial internet-of-things and high performance computing.

### Outlook

The Fund remains positive about the outlook for the Taiwan equity market and the long term structural trends in certain areas of technology as referred to above. Performance in the second half of 2019 may see the benefits of stronger growth momentum. However, the current market optimism may be vulnerable to sudden reversals in progress on China and United States trade negotiations, monetary policies and weaker than expected smartphone sales in the second half of 2019.
