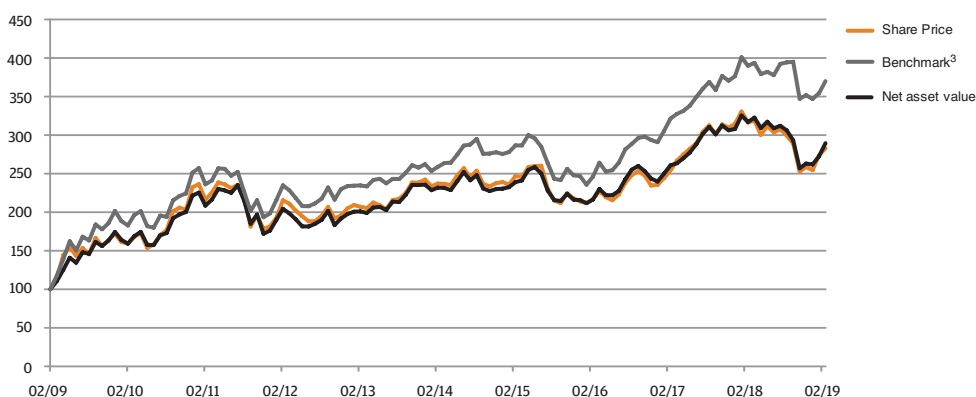

### Market review

The TAIEX Total Return Index (TAIEX) continued its increase, rising 4.4% in February. The positive factors of improved outlooks for China and United States trade negotiations and global macro-economic policies that had supported the previous months' gains continued. In addition, there were expectations of improved results for technology companies in the second half of the 2019, with companies in the automation industries outperforming mainly due to increased capital spending and new technology trends.

### Fund update

The Fund outperformed the TAIEX by 1.8% in February. This was mainly attributable to stock selection. Silergy Corp., MediaTek, Inc., Largan Precision Co., Ltd. and Hiwin Technologies Corp. were among the key contributors to the Fund's performance. In contrast, stocks that detracted from the Fund's performance included Formosa Petrochemical Corp.

There is no change to the Fund's core investment approach and the portfolio is concentrated in high conviction quality companies with strong growth profiles. The Fund's portfolio reflects its confidence in the long term growth potential of artificial intelligence, 3D sensing, industrial internet-of-things and high performance computing.

### Outlook

The Fund remains positive about the outlook for the Taiwan equity market and the long term structural trends in technology as referred to above. Performance in the second half of 2019 may see the benefits of stronger growth momentum. However, the current market optimism may be vulnerable to sudden reversals in progress on China and United States trade negotiations and macro-economic policies.
