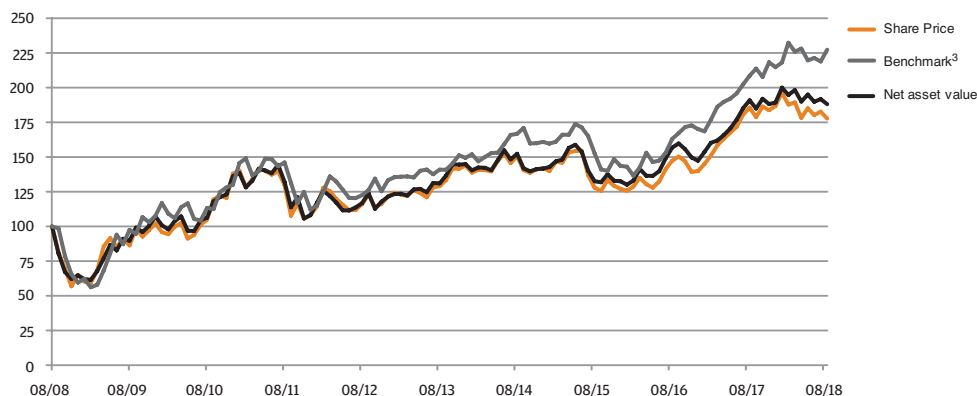

Market review

The TAIEX Total Return Index (TAIEX) rose 0.5% in August, driven by an increase in the stocks of companies operating in the energy, financial, basic material, consumer staples and telecommunications markets. In contrast, some technology stocks underperformed as investors took a more cautious view towards the impact of trade tensions between the United States and China, weakened demand for smartphones made in China and reduced sales forecasts of new iPhones.

Fund update

The Fund underperformed the TAIEX by 2.4% in August. The performance was negatively impacted by the overweight positions in semiconductor (Globalwafers Co., Ltd., Vanguard International Semiconductor Corp., Nanya Technology Corp. and Global Unichip Corp.) and iPhone supply chain holdings (Largan Precision Co., Ltd. and Pegatron Corp.). Positive contributors to the Fund's performance included its overweight position in Win Semiconductors Corp.

There is no change to the Fund's core investment approach and the portfolio is concentrated on high conviction quality companies with strong growth profiles. The Fund's portfolio reflects its confidence in the long term growth potential of artificial intelligence, 3D sensing, industrial internet-of-things and high performance computing. The Fund has underweight positions in financials, telecommunications and basic materials.

Outlook

Despite concerns around trade tensions between China and the United States and the impact of emerging market currency depreciation, the Fund remains positive about the outlook for the Taiwan equity market. Disappointing sales forecasts for the new iPhone may see a change in Apple Inc.'s pricing strategy post launch and there remains confidence in long term structural trends in technology as referred to above.
